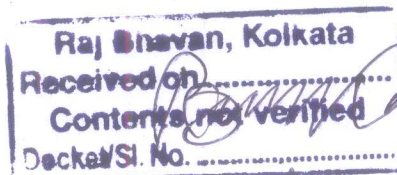

In recent time, General People and so many political party workers dying all most every day through political violence. Now, we are demanding to start a Peace Building Process with the existing political parties in West Bengal under the ambit of 'The Governor'.
